## DESCRIPTION OF LICENSES

Harvester Registration		<b>ALL COMMERCIAL HARVESTERS MUST BE REGISTERED.</b> This registration is non-transferable. (Exempt from registration: fishing guides, dealers and seafood landing license).
Fishing Guide	FGR or FGN	Allows licensee to provide services as a fishing guide in the tidal waters of Maryland, including the Atlantic Ocean within state waters <i>A Resident Fishing Guide may <u>not</u> be changed to a Nonresident Fishing Guide.</i> <b>* Must attach a copy of current USCG Captains License</b>
Finfish – Hook & Line	HLI	Allows the use of hook & line gear to harvest finfish for sale.
Unlimited Finfish Harvester	FIN	Allows the use of all legal equipment to harvest finfish for sale.
Limited Crab Harvester	LCC	Allows the use of up to 50 crab pots, trotlines, nets, dip nets, traps, pounds and scrapes to harvest blue crabs for sale. <b>**Must specify crabbing day off.</b>
Limited Crab Harvester (Male only)	LCCM	Allows the use of up to 50 crab pots, trotlines, nets, dip nets, traps, pounds and scrapes to harvest male blue crabs only for sale. <b>**Must specify crabbing day off.</b>
Crab Harvester – up to 300 pots	CB3	Allows the use of up to 300 crab pots, trotlines, nets, dip nets, traps, pounds and scrapes to harvest blue crabs for sale. <b>**Must specify crabbing day off.</b>
Clam Harvester	CLM	Allows residents of Maryland the use of all legal equipment to harvest clams for sale.
Oyster Harvester	OYH	Allows residents of Maryland to harvest oysters for sale by diving, tonging, or handscraping.
Oyster Dredge Boat	ODB	Allows residents of Maryland the use of a dredge boat to harvest oysters for sale.
Conch, Cancer Crab, Turtles & Lobster Harvester	CTL	Allows the harvest of conch, cancer crabs, turtles, or lobsters for sale.
Unlimited Tidal Fish	TFL	Comprehensive license available to residents of Maryland, covering all authorizations described above. If using this license as a Fishing Guide, you must attach a copy of your current USCG Captains License. An Unlimited Tidal Fish license may be permanently converted to its component authorizations described above. <b>**Must specify crabbing day off.</b>
Master Fishing Guide		May employ other persons to guide fishing parties on a vessel owned by the master fishing guide or out of a marina owned and operated by the master guide. <b>* Must attach a copy of current USCG Captains License</b>
Bait Harvester		Allows individuals who do not have a commercial tidal fish license to catch and sell certain species of finfish and shellfish for bait.
Crab Harvester 600 Pot Authorization	CB6	Applicant with a 300 pot Crab Harvester License or an Unlimited Tidal Fish License may increase the number of pots to 600 or 900. <b>**Must specify crabbing day off.</b> (Applicant must file an application and pay a fee to be placed on a waiting list).
Crab Harvester 900 Pot Authorization	CB9	
Nonresident surcharge		Additional fee <b>required</b> for all nonresidents of Maryland. Varies by State of residence.
Oyster Harvesting Surcharge	OYS	Additional fee <b>required</b> to harvest oysters. <b>Applicant must apply in person, by appointment only, at a DNR Service Center. Visit <a href="https://dnr.maryland.gov/Pages/License-Licensing-Appointment-Information.aspx">https://dnr.maryland.gov/Pages/License-Licensing-Appointment-Information.aspx</a> for locations.</b>
Seafood Landing License		May land fish caught in out-of-state tidal waters without a harvester's license or registration.
Northern Snakehead Bowfish		Authorizes the holder to catch for sale Northern Snakeheads in the tidal waters of the state using a bow and arrow attached to a retrieval line.
Invasive Catfish Finfish Trotline		Authorizes the holder to catch for sale Blue and Flathead Catfish in the tidal waters of the state using a finfish trotline.
Marketing Surcharge		Additional fee <b>required</b> of all commercial harvesters and dealers. If applicant is a harvester and dealer, the higher dealer surcharge will be applied.
Tidal Fish Dealer License		May process, pack, resell, market or otherwise deal in fish caught in tidal waters. Harvesters must either sell to a licensed dealer or be a licensed dealer in order to sell their catch. The dealer license is discounted for these harvesters.
Late Fee		\$50 if renewed between 9/01/22 and 3/31/23. <u>No license may be renewed after 3/31/23.</u>

Annotated Code of Maryland, Natural Resources Article, §4-701(k)(7) allows the licensee to designate an individual that may use the licensee's vessel and license. The individual indicated may be changed once in the license year. The licensee is legally responsible for all activities performed by the individual whom they have designated. Indicate the individual and their DNRid number in the appropriate box on the front of this application.

### **DESIGNATING A BENEFICIARY (Beneficiary cannot hold the same license type)**

A licensee may designate a person (does not need to be a family member) as a beneficiary of the license by indicating their name and DNRid on the front of this application. Upon licensee's death, if no beneficiary is named, an authorized representative (Letter of Administration required) may indicate a person eligible for a permanent business transfer regardless of the number of seasons the deceased held a valid tidal fish license.
