Subject: Aquaculture Declaration and DNRid

Date: October 9, 2015

In order to securely and effectively comply with the current legal and regulatory requirements outlined below, the Department is now requiring each Shellfish Aquaculture Harvester Permittee and Registrant to get an Aquaculture Declaration through COMPASS, prior to being issued a 2016 Shellfish Aquaculture Harvester Permit or Registration Card.

Why the new requirement?

The Aquaculture Division was made aware that under Maryland Law, Family Law Article 10-119.3, similar to all other commercial fisheries, we are required to obtain Social Security numbers for all commercial Shellfish Aquaculture Permittees and Registrants. In addition, recently implemented aquaculture penalty regulations require the Department to screen Shellfish Aquaculture Harvester Permit and Registration Card applicants for shellfish violations before issuing permits and to track violations.

Currently, Shellfish Aquaculture Permittees and Registrants are the only commercial harvesters that are not licensed or permitted through COMPASS using a DNRid. Integrating all of our Permittees and Registrants into COMPASS will allow the Department to collect the required Social Security numbers in a secure manner, and eliminate the need to request SSNs on a SAHP Application or Modification Form.

How do you get the Declaration?

The Department has developed a free Aquaculture Declaration in COMPASS. Each Permittee and Registrant will first need a DNRid before they will be able to obtain the Aquaculture Declaration. If you currently hold a Maryland hunting or fishing license, you have already been issued a DNRid and this number can be found in the upper right corner of the license document and again above your name in the middle of the document. The DNRid, if you do not already have one, and the Aquaculture Declaration can both be obtained in person at a DNR Service Center or online at <https://compass.dnr.maryland.gov>.

Each Permittee or Registrant will only need to obtain a DNRid and Aquaculture Declaration one time.

What does this mean for me and my workers?

Each Shellfish Aquaculture Harvester Permittee and Registrant must get a DNRid if they do not already have one and an Aquaculture Declaration through COMPASS, prior to being issued a 2016 Shellfish Aquaculture Harvester Permit or Registration Card. Please distribute this information to all Permittees and/or Registrants on your lease and encourage them to obtain a DNRid and/or the Aquaculture Declaration as soon as possible.

The 2016 SAHP renewal form that you will receive in your Annual Mailing package will show whether or not the Permittees and Registrants listed for renewal to work on your lease have obtained a DNRid and the Aquaculture Declaration. **Shellfish Aquaculture Harvester Permits or Registration Cards for 2016 will NOT be issued to individuals who have not obtained the required Declaration.**

A guidance document is enclosed with this memo to familiarize you and the other Shellfish Aquaculture Harvester Permittees and Registrants with the simple steps necessary to satisfy this requirement.

HOW TO GET YOUR AQUACULTURE DECLARATION

Once you have a DNRid, you will need to sign into your COMPASS account and select the free Aquaculture Declaration. There are two ways to access your COMPASS account using either your Username/Password or DNRid/Birthdate:

1. Visit COMPASS Online at: compass.dnr.maryland.gov
2. Visit one of the Department's Service Centers – You can locate the center nearest to you at: dnr.maryland.gov/Pages/service_centers.aspx

After you have signed into COMPASS follow these steps:


STEP 1

Your COMPASS account will show you several options for managing different activities. Under the **Services** heading, select Purchase Merchandise to see the categories.

STEP 2

From among the different categories, find **Free Registration** and click on the  to open the choices so you can see the free Aquaculture Declaration. Click the checkbox next to Aquaculture Declaration and a green checkmark will appear confirming your selection.

STEP 3

First: The Aquaculture Declaration is now ready to be added to your shopping cart. Click on the red Add (1) Item(s) to Cart (\$0.00) button, so that the declaration is moved to your cart. The button will change back to grey and the green checkmark will be gone from Aquaculture Declaration checkbox.



Second: You are now ready to click on the Proceed to Checkout button to review the transaction.

STEP 4

The Aquaculture Declaration appears in your Shopping Cart and you can now click on Check Out.

Because the declaration is **free**, the system will ask you to Complete Transaction (instead of Pay Now). You can see that the **Payments** section has 0 items, but the **Products** section has the declaration listed under Extended Price for \$0.00 as a free product.
