Application for Shellfish Aquaculture Lease – William T. Gabeler and Morgan E. Gabeler

The Secretary of Maryland Department of Natural Resources (DNR), pursuant to Natural Resources Article, §4-11A-09(g), Annotated Code of Maryland, is giving notice of an application for a shellfish aquaculture water column lease by William T. Gabeler and Morgan E. Gabeler in Purnell Bay, Worcester County, Maryland, located near shore in the bend northwest of Goose Point and adjacent to another shellfish aquaculture lease, WO 566, held by the applicants. The area applied for contains 1.9 acres more or less and is enclosed by a line beginning at corner 1, at or near Lat. 38° 1' 8.8" N., Long. 75° 22' 45.6" W., then running 295° 2' (True), approximately 51 meters to corner 2, at or near Lat. 38° 1' 9.5" N., Long. 75° 22' 47.5" W., then running 332° 8' (True), approximately 52 meters to corner 3, at or near Lat. 38° 1' 11.0" N., Long. 75° 22' 48.5" W., then running 5° 22' (True), approximately 52 meters to corner 4, at or near Lat. 38° 1' 12.7" N., Long. 75° 22' 48.3" W., then running 310° 17' (True), approximately 19 meters to corner 5, at or near Lat. 38° 1' 13.1" N., Long. 75° 22' 48.9" W., then running 69° 33' (True), approximately 41 meters to corner 6, at or near Lat. 38° 1' 13.6" N., Long. 75° 22' 47.3" W., then running 154° 50' (True), approximately 72 meters to corner 7, at or near Lat. 38° 1' 11.5" N., Long. 75° 22' 46.0" W., then running 155° 36' (True), approximately 68 meters to corner 8, at or near Lat. 38° 1' 9.5" N., Long. 75° 22' 44.8" W., then running 163° 37' (True), approximately 16 meters to corner 9, at or near Lat. 38° 1' 9.0" N., Long. 75° 22' 44.6" W., then running 256° 40' (True), approximately 25 meters to the point of beginning.

The applicants propose to place cages on bottom up to a maximum of 9.5 inches high for the purpose of culturing Eastern Oyster (*Crassostrea virginica*), and to harvest using methods approved by the Department. A map of the proposed lease is attached.

The Department will hold a public informational meeting upon written request from a member of the public. In addition, any person who has a specific right, duty, privilege, or interest that is different from that held by the general public and may be adversely affected by the proposed lease may file a Petition of Protest with the Department. Petitions that meet the requirements of Natural Resources Article §4-11A-09(g) shall be forwarded to the Office of Administrative Hearings for adjudication. Comments, written requests for public informational meetings, and/or Petitions of Protest must be received by the Department of Natural Resources Aquaculture and Industry Enhancement Division 580 Taylor Avenue E-4 Annapolis, MD 21401 by July 1, 2019. 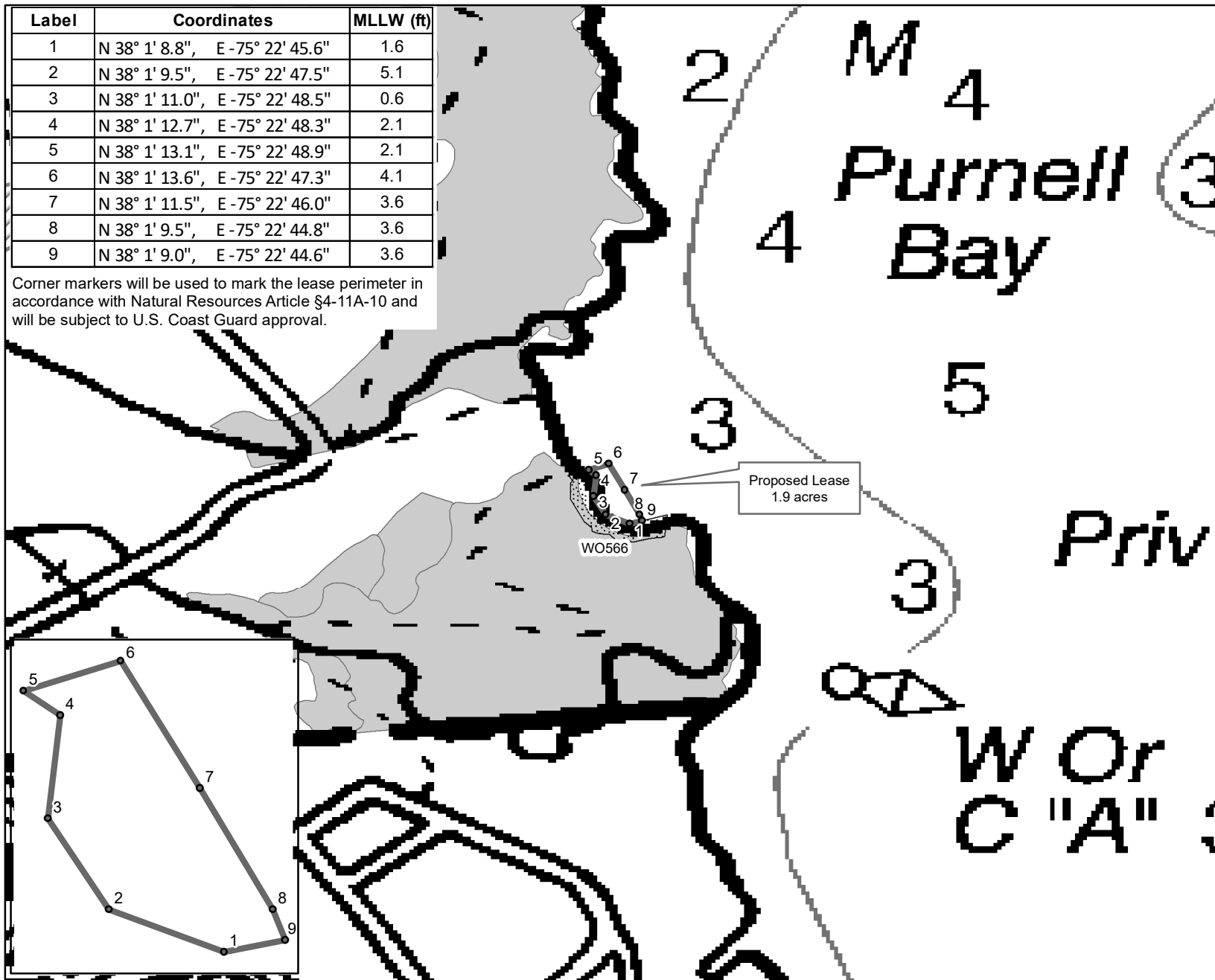
