# Minutes of the Garrett County Forest Conservancy District Board Meeting (Virtual Meeting) March 8, 2021

#### Call To Order:

The Hickory arboretum project will be funded through Gift of Trees, rather than MUCFC. Trees have been ordered and will arrive in early April.

#### **Deep Creek Lake Watershed Foundation**

The foundation may be interested in helping expand Backyard Buffers, rain barrels, promoting the planting of edible landscapes and recognition programs for participating homeowners.

## **Watershed Update**

Gary reported that the new MOU has been signed. The aquatic invasive species website and social media information is still being worked on.

We may not pursue a raffle again this year unless we are able to sell tickets at the fair and Autumn Glory.
