I. INTRODUCTION

The Carroll County Land Preservation, Park and Recreation Plan (LPPRP) continues to serve as a guide determining funding priorities for the Carroll County Department of Recreation and Parks. The plan uses previously collected input to help determine priorities for both land preservation and park development. Over the Department's 50-year history, Program Open Space has played a vital role in providing recreational opportunities to Carroll County's residents and visitors. The FY 2023 Annual Program focus on maintaining and improving existing park infrastructure to ensure continued safe usage as well as address new and growing needs expressed by residents.

II. PLAN OBJECTIVES

Projects included in the FY 2023 annual program pursue goals/objectives previously stated in the Land Preservation, Park and Recreation Plan including:

- Direct funding towards designated growth areas when possible to serve largest number of residents
- Provide recreational opportunities for all citizens
- · Address aging park infrastructure to ensure continued safe usage of existing facilities
- Address increased demands from citizens as county demographics continue to change for facilities such as trails, especially in areas that do not currently feature these opportunities

III. PROJECT PRIORITY AND SELECTION PROCESS


Proposed capital project requests are developed annually after receiving input from the public, volunteer recreation councils and the County's eight (8) municipalities. Requests are presented to the County's Recreation & Parks Advisory Board, an 11-member citizen board with representation from each of the County's five (5) Commissioner districts. During project evaluation, factors such as consistency with the County's LPPRP and department goals, available funding, and costs/benefits are all given consideration.


New recommended county projects are typically added in the County's 6-year capital improvement plan's outermost year and work their way forward as funding support allows. In addition, Carroll County annually accepts projects from the municipalities with four (4) towns typically receiving funding each year on a rotating basis. All recommendations are forwarded to the County Commissioners for their approval and projects are ultimately added to the department's capital improvement plan.



NW Regional Park – Location Map







Attachment 1 – Piney Run Park Location Map



Town of Hampstead City Road Map




