CHAPTER 1 INTRODUCTION EXECUTIVE SUMMARY

The Garrett County Land Preservation, Parks and Recreation Plan guides the future use of funds made available to the citizens of the County by the State of Maryland and the Federal government for the preservation of open space and for providing and improving recreational opportunities. By enumerating the goals, plans, and policies guiding the use of those funds, the County ensures successful investments to the population's quality of life. The Plan is scheduled to be adopted by the County Commissioners on or before July 1, 2022.

PURPOSE

The State of Maryland requires that counties update their Land Preservation, Parks and Recreation Plan (LPPRP) every five years; one year following the revision of the statewide Maryland Land Preservation, Parks and Recreation Plan. Garrett County's LPPRP identifies future needs and priorities for parks, recreation and open space acquisition, facility development and rehabilitation in the County and its eight incorporated towns. These needs and priorities serve as a guide for land acquisitions and capital investments in the County's and towns' Capital Improvements Programs. Upon adoption, this 2022 LPPRP replaces the 2017 LPPRP and becomes one of several functional plans that informs implementation of the Garrett County Comprehensive Plan.

The LPPRPs qualify local governments for State Program Open Space (POS) grants, and other programs related to three land resource elements: recreation and parks; agricultural land preservation; and natural resource land conservation.



CHAPTER SUMMARY

Chapter 1 provides general geographic information, population, and demographic information. Plus, an introduction to the entire system of public parks and recreation facilities, preserved natural resource lands, and agricultural land.

Chapter 2 includes a Parks and Recreation executive summary and an overview of the parks and recreation system in the County. This chapter also includes a summary of parks and recreation focused information including relevant summary information from existing County plans and other pertinent public information and directs readers to other plans, program documents, reports or resources that provide more in-depth information. A discussion of County and state goals concerning parks and recreation, a list and summary of programs/funding sources used to achieve those goals, inventory of existing public parks and recreation facilities, a discussion of user demand, a level of service analysis followed by a discussion of the capital improvement plan to address the findings of the public outreach and analysis is also provided.

Chapter 3 is the Natural Resource and Land Conservation chapter and includes an overview of Natural Resource land conservation in the County along with County goals for natural resource land conservation. Included is an inventory of protected natural resource lands, mapping, and a plan for implementing ordinances and programs.

Chapter 4 addresses Agricultural Land Preservation in the County along with County goals and contains an inventory of existing preserved agricultural land and associated mapping.

PROCESS

The 2022 LPPRP was prepared by the Garrett County Department of Planning and Land Management (the Department). This 2022 LPPRP was developed in accordance with guidelines developed in 2021 by the Maryland Departments of Planning and Natural Resources. The 2022 LPPRP references and incorporates information from the 2017 LPPRP prepared by the Department. In addition, data and information from various other County documents are included where relevant. Documents reviewed for this plan are listed in

The eight towns in Garrett County were contacted and consulted to update the recreation inventory, provide user data, review past recreation projects, and for localized public outreach. Summaries for each municipality can be found in Appendix C, Appendix D, Appendix E, Appendix F, Appendix G, Appendix H, Appendix I, and Appendix J.

The Department met with staff, the public, stakeholder groups, and held public outreach meetings for input to this plan. In addition, beginning in September 2021, the Department released an on-line survey to the public seeking input and comments in identifying needs and future priorities. The survey was advertised in local papers, utilizing local organization's email listings, and via the County website. The survey was available until November 2021.

A draft of this plan was completed in winter 2022 and underwent internal review. It was then sent to the eight municipalities and forwarded to the DNR and MDP for initial review and comment. Comments were received and incorporated into the document. The Garrett County Planning Commission reviewed the draft in March of 2022

during their regular monthly public meeting. A public draft of the plan was released online on May 19, 2022 and public comments were open for 21 days. After subsequent inclusion of more comments the document was forwarded to the Board of County Commissioners in June of 2022 and adopted the plan.






FIGURE 4 PICKLEBALL AT GRANTSVILLE COMMUNITY PARK

GEOGRAPHIC INFORMATION

Garrett County is Maryland's westernmost County. It is bordered to the north by Pennsylvania along the Mason–Dixon line to the south by the Potomac River and West Virginia, to the west by the Deakins line border with West Virginia, and to the east with Allegany County, Maryland. Garrett County contains eight incorporated towns: Accident, Deer Park, Friendsville, Grantsville, Kitzmiller, Loch Lynn Heights, Mountain Lake Park, and Oakland. See Map 1 for a locational map.

The County is located entirely within the highland zone of the Appalachian Mountains, also known as the Allegheny Mountains, the Allegheny Plateau, and the Appalachian Plateau. The County's highest elevations are located along four ridges that range to a height of 3,360 feet at Hoye-Crest along Backbone Mountain, the highest point in the state of Maryland. The morphology of the Allegheny region is characterized by broad flat lands below the ridge crests that range in elevation from 2,500 to 3,000 feet. The center of the County is dominated by Deep Creek Lake, the largest inland body of water in Maryland with 69-miles of shoreline, and an elevation of 2,462 feet above sea-level. The lake is home to a wide variety of freshwater fish, and aquatic birds and covers approximately 3,900 acres.

Garrett County straddles the Eastern Continental Divide. The western two thirds of the County drains to the Gulf of Mexico via

the Monongahela-Ohio-Mississippi Rivers system. The primary rivers in the system are the Youghiogheny River that drains the western and central part of the County and flows north from the County's central section into western Pennsylvania. The eastern third of the County drains in the Chesapeake-Atlantic via the Potomac River. The Savage River is in this basin and empties into the Potomac at Bloomington. Garrett County is the second-largest County in Maryland by land area. Garrett County contains

approximately 419,667.2 acres (655,523 acres of water¹ 1.3%) and 414,144.00 acres 98.7% of land. The 2010 Land Use Summary from the Maryland Department of Planning indicates that approximately 284,457 acres (68%) of the County is forested, while about 89,323 acres (21%) is used for agriculture and approximately 1% is water cover. Most of the remaining 41,797 acres (10%) of total developed lands in the County are in and around the eight towns, areas in proximity to interchanges of Interstate 68, and around Deep Creek Lake. A total of 377,496 acres within the County (90%) are listed as resource lands

The County contains over 94,262.8 acres² of parks, lakes, and publicly accessible forestland, approximately 68% of the County's land area

Garrett County's natural resource assets include scenic and wild rivers, three significant manmade lakes,

large tracts of forested areas, and rolling rural landscapes of the Allegheny Mountain. The County's natural beauty is appreciated by residents and outdoor enthusiasts that regularly visit the County's many state parks and forests, for its hunting, fishing, biking, world-class whitewater, boating, and winter sports opportunities. The County benefits from recreation and resource land owned by the State of Maryland, other governmental agencies, the towns, large private tracts owned by mining, and timber companies and various conservation organizations.

POPULATION & DEMOGRAPHIC INFORMATION

Population Overview Residents & Visitors

Though the population of Garrett County averages 30,000 residents, visitors are attracted by the County's recreational opportunities. The County has a strong tourism sector, with Deep Creek Lake as the main attraction since its construction in 1925. The Garrett Chamber of **Total Population** Commerce estimated 1,398,150 annual visitors in 2019 based on 2,400 visitor surveys from the 2020 Census height of the COVID-19 lockdowns from March 2019 through February 2020. Garrett County's demand in outdoor and recreation declined during the COVID-19 pandemic but has made a strong recovery, as seen in the 103% increase in direct Annual Visitors commuter tax impact from fiscal year 2019 to 2020³. 2019-2020 Travel /Tourism Related Economic I Analysis While these visitors and seasonal residents do not count toward the County's year-round population, they have impacts on community services and resources, like recreation and transportation. Garrett County recognizes its outdoor recreational assets and strives to balance economic development while protecting our natural resources. Since the visitors and part-time residents utilize Garrett County's recreation assets, this plan exceeds the recreation demands of the residents of Garrett County, to provide capacity for visitors while protecting our natural resources.



Garrett County's population skews mature with the median age of 42.6 (2020 Census), while the national median age in 2020 is estimated at 38.31. In 2019, an estimated 22% of the County's population was age 65 or older (compared to 11% statewide). This age group is expected to grow to 27% by approximately 2025. While the total projected increase is a change of only 1,103 persons, there is a significant change in age distribution. The population age 19 and under is projected to decrease by approximately 879 persons and will represent 21% of the population, down from 25%. The population age 65 and over is projected to increase by about 2,179 and will comprise 24 % of the population in 2025 compared to 17 percent in 2010.





POPULATION DISTRIBUTION

Garrett Couty's incorporated towns account for only 12% of the County's population, but they own and operate many parks, playgrounds, and sports facilities. In planning the future development of parks, recreation, and natural resource conservation projects the following factors are considered due to the size and lack of population density in the County: travel time, parking, availability of volunteers (for coaching & maintenance), coordination, scheduling maintenance, fundraising, infrastructure, local law enforcement, and weather.

Municipal population trends have declined. 2010 to 2020, except for Mountain Lake Park which has increased five percent. Much of the growth in the County has been centered around the Deep Creek Lake, in McHenry and the Deep Creek Watershed, which is not a municipal area, but rather a location and watershed.

Though future population growth is expected to be modest, this LPPRP assumes increased leisure time for residents, due to the retiring population, and increased visitors and part-time residents. The local economy of the region is dependent on providing the amenities that fulfill the needs of the resident population and to draw visitors. The County's numerous parks, preserved land, accessible local, state, and privately owned



forest land and other recreational opportunities are especially important to attract these visitors and sustain the needs of the County's residents. Other considerations are the recreational needs of the aging resident population, the changing popularity of lower impact/ lower intensity sports activities, and the improvement in information technology and internet access that allows for longer visits and added recreational activities.







FIGURE 11 FORK RUN MOUNTAIN LAUREL



Overview of Preserved Lands and Natural Resources


Garrett County has an abundance of park, trails, public lands, natural resource lands, and agricultural lands. Due to the density of these recreational opportunities and land preservation features the following series of maps have been developed for viewing Garrett County's Parks Inventory, Natural Resource Areas, and Land Preservation.

Map 1 illustrates Garrett County's Parks Inventory. The map includes parks and recreational sites owned by municipalities, the Garrett County Board of Education, and state and federal agencies. The County does not have a designated Parks Department to operate or maintain any parks or recreational sites. Certain water features are included as sites for public recreation. All publicly accessible water features are also included, as all of those sites are used for rafting, kayaking, or fishing.








Map 2 illustrates Garrett County's Natural Resource Areas. We have defined those areas as state and federal owned lands, forested areas, and water features. All state and federal owned lands are forested but not all forested areas are state or federally owned, so overlap exists between these features as well.



Map 3 depicts Garrett County's Land Preservation mapping. Depicted on this map are easements and districts associated with the Rural Legacy, Maryland Agricultural Land Preservation Foundation (MALPF), Garrett County's Agricultural Preservation District, and Maryland Environmental Trust (MET) Easement programs. Each of these maps and their associated programs will be discussed in more detail in the following chapters.

CHAPTER 2 PARKS AND RECREATION OVERVIEW OF PARKS AND RECREATION

SYSTEM

Garrett County has a robust system of parks and recreation and natural resources lands, yet the County does not have a dedicated Parks and Recreation Department responsible for operating and maintaining County owned parks, trails, and open space. Over the years the County has maintained relationships with non-profit organizations like the Deep Creek Lions Club volunteers, Garrett Trails, and Towns, Board of Education, and other partners to develop, program, operate, and maintain public recreation assets. Appendix K is a proposed scoring matrix for objectively prioritizing recreation funding requests based on the goals in the LPPRP. The County administers Program Open Space funding, and the Board of County Commissioners decide the allocation of Program Open Space funds. The Board of County Commissioners retains overall responsibility for coordinating the POS program throughout the County. The County coordinates Program Open Space land acquisitions in the unincorporated part of the County and land so purchased is titled to the County. Program Open Space land acquisitions in, or for, municipalities are handled by municipal agencies. Municipalities and community organizations are responsible for development of facilities, with the guidance and consent of the Board of County Commissioners.

The County facilitates public outreach Countywide and for the municipalities to assess whether recreation demands are met and to assure that new projects meet the needs of the community.

PUBLIC PARKS AND RECREATION INVENTORY


An updated inventory of existing public parks and recreation facilities in Garrett County was prepared in 2022 (Map 4.) The data were utilized in preparation of the 2022 LPPRP, The majority of these facilities are owned and maintained by the towns they serve within the County. Because additional parks and recreation facilities are outside the Towns and not owned by the County the are subject to Stae or federal laws and regulations for these reasons natural resource and agricultural lands are discussed separately in Chapters 3 and 4, respectively. is provided in this chapter. This inventory was completed as part of the 2022 LPPRP and that data was used as a basis for the inventory. A map that shows the location of the County's parks and recreation facilities can be found in this chapter and in Appendix B.

PARK CLASSIFICATIONS

Park and Recreation Facilities are classified to assist in planning for the community's recreational needs in Table 4 Park Classifications. The park system provided by Garrett County and its partners is composed of a hierarchy of park types offering different active or passive recreation and/or natural area opportunities. While each park facility may serve only one function, collectively the system is intended to serve the full

range of community needs. Classifying parkland allows the park and recreation providers to evaluate those needs and to plan for an efficient, cost effective and coordinated park system. Classifications are not meant to be static, and they can change over time as conditions change. While the classifications are guidelines for identifying the targeted sizes, use, and amenities for each park type, acquisition opportunities and site

characteristics will also influence park development.

COUNTY PARKS

Garrett County does not directly operate or maintain the nine County-owned parks and recreation lands. Local groups and organizations are responsible to operated and maintain parks under lease agreements with the County. For example, although the Casselman Valley Soccer Complex is owned by Garrett County, the Casselman Valley Soccer Association's volunteers are responsible for upkeep, scheduling, and obtaining funding for improvements. The Deep Creek Lions Club Park is County owned and the volunteers of the Deep Creek Lions Club organization maintain and develop the park and the system of hiking and mountain bike trails on adjacent County land. The Department of Public Works-Roads Division continues to provide inkind services that include labor and/or materials for park and trail improvements. This cooperation is often leveraged as in-kind match for grant funding.

The County Commissioners own the Adventure Sports Center International (ASCI), which was home to the 2014 ICF Canoe Slalom World Championships. The complex includes a manmade white-water course near Deep Creek Lake. The facility is operated by Wisp.

MUNICIPAL & COMMUNITY

The County's eight towns have their own town community parks in their jurisdiction. The Towns' small staffs and volunteers maintain and operate Community Parks. The towns fund their parks and programs through a variety of sources, such as Program Open Space, Community Parks and Playgrounds, and other grants. The towns apply annually for POS funding through the County to maintain, update, and enlarge the existing parks and recreation opportunities in these communities. The towns or other organizations provide the ten-percent match required for POS grants. The County Commissioners allocate annual funding requests from the towns. In addition, the City of Frostburg, a municipality in Allegany County, maintains and operates the Piney Reservoir, the drinking water source for the City, located in Garrett County. Piney Reservoir is a popular fishing location.

School Facilities

BOARD OF EDUCATION

Public recreation facilities that are owned and maintained by the Garrett County Board of Education and Garrett College are an especially important part of recreation provided in Garrett County. The Board of Education maintains eight elementary schools, two middle schools, two high schools, and the Hickory Environmental Center. All have a variety of playgrounds, athletic and walking paths. The Board of Education annually updates its Comprehensive Maintenance Plan for Educational Facilities for Garrett County ⁷. In the annual updates, Garrett County Planning and Land Management review the plan to allocate Program Open Space or other grant funds to improve these public facilities. Educational recreation developments funded through POS are coordinated by the Board of Education, which acts as the Local Sponsor as described above under the terms of a Joint Use Agreement cosigned with the County.

Garrett County's current trail inventory calculates over 350 miles of hiking and biking trails. Since the 2017 Recreation Plan, many miles of trails have been developed under the direction of Garrett Trails, Garrett Trails is a nonprofit, volunteer organization dedicated to the development of a well-used network of high-quality, sustainable trails that provide access to Garrett County's historic, municipal, and environmental treasures which link to trails outside the County. Most recently the group has been working on the Meadow Mountain segment of the Continental Divide Loop trail system. Trail alignment and design have been completed and the group has tentative approval for construction of a segment of the trail.

In addition to their work on the Continental Trail Loop, they have also recently been working with the Department of Planning & Land Management and Garrett College in developing a trail network in McHenry that has its initial focus on providing a safe walking path for students from Garrett College to various points in the McHenry area including US 219 up to Pysell Road. Many of

these students do not have vehicles and walk to the grocery store, urgent care, and many other places in the area. Currently no off-road path is available to them, creating a dangerous situation for both pedestrians and motorists.

Garrett Trails have received a grant and purchased an adaptive trail machine to take people with mobility challenges on the hiking and mountain biking trails.

Other Garrett Trails Projects being pursued include but are not limited to: ASCI to Fork Run, Fork Run to Swallow Falls, Swallow Falls to Oakland, Connectivity of all municipal trails, Meadow Mountain to Meyersdale, PA, Jennings Rail Bed to Grantsville, Friendsville to Youghiogheny Lake, Friendsville to Sang Run, the Deep Creek Lake Lions Club Trail, Deep Creek Lake State Park (Phase II and III), and the 4H Camp

community. In 2021 over three miles of trails were constructed and now open to the public.

In addition to hiking and biking trails, On Highway Vehicles (OHV), Off Highway Recreational Vehicles (OHRV), motorcycles, All Terrain Vehicle (ATVs), and snowmobiles are very popular in Garrett County. The State has developed Saint John's Rock and Wolf Den Run State Parks to provide trails for these users. In addition, Garrett County offers permits to register ATV's and allow users to operate on Garrett County roadways not exceeding 2-miles. In 2022, the Maryland General Assembly expanded the definition of "all-terrain vehicle" in provisions governing the use of all-terrain vehicles and snowmobiles in Allegany County and Garrett County to include offhighway motorcycles; and expanding the area of a highway from 2 miles to 5 miles on which Allegany County and Garrett County may authorize all-terrain vehicles and snowmobiles to operate this is to go into effect as of October 1, 2022.⁸ See Map 5 Recreational Vehicle Access Map.



Garrett County contains nine State Parks which see about 120,000-dayusers annually. These parks are an attraction to Garrett County's visitors and are utilized by the residents. During the COVID 19 Pandemic the parks were at full capacity in Garrett County and throughout the state. In response to highlighted importance of these facilities the State convened a State Park Investment

Commission that published a report in December 2021 with forty recommendations to increase capacity, provide access, conserve the state's natural resources, and to invest in recreational opportunities across the state.

Since the 2017 LPPRP the State has invested in Off-Road Recreational Vehicle ORV and hiking trails and facilities. St. John's Rock and Wolf Den Run are popular destinations for off road vehicles.

Federal Lands

Federal lands in Garrett County are both projects owned and operated by the U.S. Army Corps of Engineers, Jennings Randolf Lake and the Youghiogheny River Lake.

The Jennings Randolph Lake Project's primary purpose is to control floods originating on the North Branch Potomac River, provide an adequate supply of water for domestic and industrial uses, and increase downstream water quality in the North Branch Potomac River. A major secondary use of the project lands and waters is recreation and environmental stewardship of natural and cultural resources. The Lake is heavily utilized by individuals and groups from near and far who participate in a variety of activities, like camping, boating, fishing, hiking, picnicking, and enjoying the great outdoors. The Maryland Department of Natural Resources constructed and operates a boat launch, to provide access to the lake from the Maryland side. The site includes a boat launch, a restroom facility, and paved parking lot. Maryland DNR charges a nominal fee of five dollars for use of the boat ramp. Maryland DNR also maintains the Robert S. Brown Overlook and a grant-funded 22-acre habitat restoration area within their leased land. There are no known planned improvements to the existing Maryland DNR Boat Launch.

The 2019 update to the Jennings Randolf Reservoir includes improving, extending, and adding designated natural surface multiuse trails, improving, and enhancing the overlook areas, and establishing hike-in and boat-in camping areas.

The Youghiogheny River Lake is 4,323.18 acres and became fully operational in 1948. Due to it location, it



is managed via outgrants to multiple jurisdictions. The Government outgrants 1,879.8 acres of land and waters to the Pennsylvania Fish and Boat Commission, 829.3 acres to the Maryland Department of Natural Resources, 55.4 acres to Laurel Highlands Outdoor Center (Yough Lake Campground), 10.8 acres to Leskinen Enterprises LCC (Yough Lake Marina), and 9.1 acres to the Town of Friendsville.

The Mill Run Recreation Area provides water access, and is operated and managed by the U.S. Army Corps of Engineers. Its year-round facility includes 30 tent only campsites, a restroom, playground equipment, a popular swim beach, boat ramp and a trailer dump station.

The U.S Army Corps of Engineers have updated the Lake's Master Plan. Improvements in the plan include increasing coordination and partnerships, facility modernization such as development of a Project Check-In app; extending Fisherman's Trail and adding in new multi-use trails; and adding in courtesy dock & shower facilities to Mill Run Recreation Area.

The Master plan identified that the areas that need most improvement are the access road across the dam and the road leading to Mill Run Recreation Area, adding a courtesy dock to Mill Run Recreation Area, and expanding the no-wake zone near Yough Lake Marina at the Route 40 bridge. There is also interest in having Wi-Fi availability at the Outflow Recreation Area campground.

PRIVATELY OWNED

Garrett County is home to successful outdoor recreation due to its unique location, high concentration of public lands, large scale visitor attraction (i.e. Deep Creek Lake), and well established recreation facilities. The Wisp Ski Resort, located in the center of the County near Deep Creek Lake, is home to the County's winter-tourism industry. The Wisp operates a ropes course and a canopy tour, golf, biking, a mountain coaster and other all-season activities. Table _ lists the inventory of other private recreation options located in Garrett County.

Garrett County has numerous creative and outdoor recreation development opportunities that require relatively small amount of effort and are relatively low risk opportunities like providing tours, increased marketing efforts, art co-ops, outdoor workshop series, and increased family focused activities. Prospective business or fundraising opportunities that would require significant organization and effort but can be done with existing resources are outdoor race series/events, creation of indoor recreational actives and expansion of existing outdoor recreation facilities. The combination of a public park and recreation business amenities creates a compelling picture of the wealth of affordable, high-quality recreation opportunities.

In addition, Garrett County Economic Development Department in partnership with Allegany County is working on attracting Recreational Manufactures to the area. The area's array of recreational natural resources would aid such manufactures in developing and selling their products.

Public Outreach

COUNTY-WIDE RECREATION SURVEY

The Garrett County Planning Department developed and distributed a County-wide online Survey which collected 706 responses from September through November 2021. The response rate was 2.5% of the 2020 total population of 28,806. This survey was advertised and promoted at various events throughout the response period.


Age Distribution


The response rate skewed from the 2019 census age distribution, as a result of non-resident respondents. The median age of Garrett County Residents according to the 2019 American Community Survey is 42.6 years old. Over 51% survey respondents identified as Baby Boomers (ages 73-55.)





Takeaway: Results may skew in survey for mature residents in the County. In future surveys, outreach through Garrett County Schools may provide responses that reflect a more accurate age distribution for Garrett County.









Resident or Visitor?


Since Garrett County has a strong tourism industry, the survey asked if they were County residents, visitors or second homeowners. Over 53% of respondents were County residents.



Frequency

The survey asked how often people participate in recreation activities; most (43%) participate a few times a week, 24% responded they recreate daily and zero people responded they never participated in recreational activities.








Adequate Recreation

When asked if people were able to recreate as often as they would like to, there was an even split 50%. Those who responded No, they do not recreate as of often as they'd like cited lack of time 46%, followed by lack of facilities 26%. This make sense for a rural county, where time is often needed to travel to recreational facilities.



Takeaway: Provide more convenient locations for recreation to be incorporated into the resident's lives. Investigate lack of facilities perception.



Recreation Activities

To gauge the popularity of recreation activities, we asked what recreational activities people like to particpate in. There was no limit on how many types of activites they could choose. The top responses wer hiking, walking, motorized boating, paddling, nature watching, fishing, swimming, picnicing, downhill skiing, use of public beaches and camping.

Takeaway: The level of service analysis will objectively review the distribution of the top uses: trail access, water access, and picnic facilites comparted to the distribution of the population in Garrett County to determine if there is adequate opportunity and facilites for the top activites.



Programing Development


To prioritize projects that encourage people to use the existing recreation facilites the survey asked "What would make you visit the parks, trails, and recreation facilities in Garrett County more often?" The top responses were:

- Better walking connections to the park (49.3%)
- Festivals (41.1%)
- Performances (39.3%)
- Better information about park events (32.2%).

The County would like to prioritize safe walking and non-motorized connections throughout the County, raise awareness of facilites and programing, and streamline the process for programming park activites, like finding venues, and advertising events.

Takeaway: Trail and pedestrian connections to existing facilities will be prioritized. Work on improving information about existing parks, to streamline organizations and residents to program and market events in public spaces.





Mode


The Plan requires the County to do a needs analysis, to determine if there are any gaps in access. To develop the analysis method, we asked about mode of transportation in accessing. As expected over 55% of people drive to access recreation, but there many responses for walking, biking, and using an off-road vehicle for access

Access

The Plan requires the County to do a needs analysis, to determine if there are any gaps in access. To develop the analysis method, we asked about preferred duration of travel to access recreation.

42% of respondents are willing to travel for 15 to 30 minutes to their recreational activies, followed by 18% willing to travel 30 to 45 minutes.

Takeaway: Anaysis should target drive times from 15 - 30 minutes.





Facility Development

To assist the County in planning future recreation projects we asked What types of recreational facilities are we missing in Garrett County?

Top requests were:

- Ice Skating rinks or trails,
- Fitness Trails,
- Nature-based playgrounds,
- Indoor Sports Facility,
- Splash Pads.


It is true that Garrett County is a four-season recreation haven, but there is not an iceskating facility. There was a high request for Fitness Trails, which there are existing trails located in the town parks of Accident and

Friendsville. An indoor sports facility was also a high request, though more information is needed to determine what kind of indoor facility would benefit the County along with finding a location.

Takeaway: Plan will review feasibility of top requests in this plan's capital improvement section.



Volunteers

Since many of Garrett County parks and recreation facilities are managed and programed by volunteers, the survey looked into future volunteer prospects. Most survey respondents were willing to volunteer on various activities, only 41% responded "No thanks." Respondents will be contacted for future volunteer opportunities.





General Comments

Figure 25 shows a word cloud, with the culmination of all the comment responses received from the recreation survey. Complete responses are in the Appendix on page 108.

Municipal Outreach

County Staff met with the Town of Oakland, Town of Accident, Town of Friendsville, Town of Grantsville, Town of Kitzmiller, Town of Loch Lynn, and Town of Mountain Lake Park to discuss their past recreation projects, gather usage data, provide outreach to their residents to gauge interest for future park projects and develop the Capital Improvement plan at the end of this chapter. The following table summarizes the public outreach for each municipality. The County Planning Department looks to continue this collaboration in future iterations of the Land Preservation Parks and Recreation Plan. Public Outreach materials and notes for each of the Towns are in the Appendix.




FIGURE 26 TOLLIVER FALLS




LEVEL OF SERVICE ANALYSIS

To visualize the level of service to determine deficiencies in park and recreation access, the County conducted both a proximity analysis and a park equity analysis. The proximity analysis determines access of all parks and popular amenities. The park equity analysis identifies underserved populations without easy access to recreation.

Proximity Analysis

Based on the survey, 5-mile buffers were applied to park and recreation access points to approximate 15to-30-minute drive times to public parks, access to trail heads, water access, and picnic areas. Address points are assigned to residences and commercial buildings. A heat map of County address points was

generated to approximate the distribution where people live and work in the County. Garrett County's most densely populated areas are in Oakland and around Deep Creek Lake. The population densities compliment the State Parks and Forest and steep slopes in the County. The buffers overlayed with the population distribution will visualize gaps in park and recreation facilities.




Recreation Distribution Analysis Garrett County, MD

The first proximity analysis, selected of only public recreation points and applied non-dissolved 5-mile buffers overlayed with the heat-map of address points. The result of this overlay is nearly complete coverage of the County, except for the area around Gorman which is not densely populated. Most of the land use in this area is extractive, forest, and agricultural. In addition, an area that is not coved is the ridge of Backbone Mountain.




Takeaway: There is adequate coverage of existing public parks in Garrett, County.




The following proximity analysis focuses on the most popular recreational uses based on the recreation survey for trail access, water access and picnicking.

In the trails analysis, recreation points that provided access to trails were selected. This included community walking tracks, athletic tracks, hiking, mountain biking trails and ORV trails. Again, for each trail access site non-dissolved a five-mile buffer was created. The buffers are transparent to visualize the density of sites and to allow the address point overlay. The only gap in this map is in Southern Garrett County, which is not densely populated but could provide connections to the other trails in Davis, West Virgina. Direct access to West Virgina through this area is provided by US 219 which is not suitable for bike and pedestrian activities. In addition, terrain in this area is challenging.





Many respondents to the recreation survey favored boating, paddling, swimming, fishing, and nature watching. All these activities require or are enhanced by access to water. Garrett County contains four man-made lakes and many rivers. Once again, the County is well covered by 5-mile buffers with access to water, except for the southern tip of the County. The eastern border of the County is the Potomac River, but access is not desirable for public recreational activities, due to lack of parking, access via vehicle, and typically low flows. Just south of Garrett County there are other public recreation water access points in West Virginia at Blackwater State Forest, Town of Thomas, Town of Davis, and Mount Storm Lake.




MAP 9 WATER ACCESS PROXIMITY ANALYSIS

Takeaway: There is adequate water access in Garrett County and our region provides near-by opportunities for water access in southern Garrett County.



Lastly a proximity analysis, which used the same method but selected for access to picnic areas that included picnic tables and pavilions. There is nearly complete coverage of picnic facilities in Garrett County, except for the County South of MD 50, which is not densely populated due to the steep terrain.




MAP 10 LEVEL OF SERVICE ANALYSIS FOR PICNIC AREAS

Takeaway: There is adequate picnic facilities in Garrett County. As a note, future recreation inventories for Garrett County should look at accessibility of picnic locations and facilities to plan retrofits that incorporate universal design and adaptive features.



Equity Analysis

We utilized the Maryland Park Equity Mapper⁹ application that combines demographic and environmental health data from a variety of sources and maps that data onto Maryland census block groups to identify disparities in park access and quality. This application allows users to evaluate the green space available in their community and see how it compares to the rest of Maryland. The Park Equity Mapper visualizes underserved communities or underutilized by existing park space communities. The Park Equity Map uses a combination of population density, low-income status, percent of children under 18, percent of adults over 65, non-white population, park distance score, public transit score, and walkabity index score.



MAP 11 EQUIITY ANALYSIS


Garrett County is a rural community with a large area and with that come challenges in distributing public services. The County's Park equity score varies greatly throughout the county. First we will examine the five factors that contribute to the score. Based on this analysis Southern Garrett County has the lowest equity, mainly due to low walkability score, and distance to public parks. This area of Garrett County is not appropriate for future park development due to the terrain, mainly agricultural or extractive land use and lack of infrastructure. Instead of developing trails, non-motorized access to the north of the County should be investigated to provide safe access to the recreation facilities in Oakland, Mountain Lake Park and Loch Lynn.

The other census tract that has a low equity score is around Deer Park, though some of the public



recreation facilities that exists were not identified in this Mapping Tool.

Takeaway: Garrett County parks equity analysis shows the County's vulnerable populations have sufficient access to parks. The areas identified with the lowest equity scores have low population densities and geographic barriers making park development unnecessary. Much of the land in this block group is owned by private hunting clubs land or mining operations. In addition, the residents in the southern part of Garret County have access to public parks in West Virginia.







This map shows distance to public parks, though there are parks in Deer Park, Kitzmiller, Loch Lynn Heights, and Crellin that are not included in this analysis. Walkability is a challenge in a county with a large area like Garrett not to mention barriers presented by terrain and lack of walking infrastructure. According to this analysis the least walkable areas are in western and southern Garrett.

This plan's implementation can increase park distance score, which is low, and make progress toward improving walking access to local parks is important.

To verify our conclusions of this analysis we referenced the 2021- 2024 Garrett County Health Inequalities Analysis, developed by the Garrett County Health Department.¹⁰ This report mirrored the low minority rates, and higher poverty rates. Though it's worth noting "previous analysis of the region has focused on economic inequities, we are expanding the conversation to include racial and LGB inequities.... While these populations are small comparatively, these statistics present insurmountable difficulties for racial and sexual orientation minorities in our community and warrant further examination and consideration in developing equity-based practices to improve population health."

The community is working toward making recreation more accessible to the economically disadvantaged. For example, in Spring 2022 the Garrett County Health Department is giving away Annual State Park passes, CARC passes, and Wildwood Athletic Center passes will be available for Garrett County residents while supplies last to provide direct access to fitness opportunities at no cost, removing a barrier for our most vulnerable residents.

Takeaway: Park and recreation facilities are adequate in Garrett County, though continuing to develop a county wide trail network and pedestrian access will increase equity to parks.

IMPLEMENTING PROGRAMS

Administration

The Planning Department is responsible for organizing and administrating Maryland Department of Natural Resource (DNR) Program Open Space (POS) funding for Park and recreation development and acquisition projects. The Planning Department collaborates with the towns and organization to draft the Annual Plan and completing funding applications. The Planning Department oversees land preservation programs, and coordinates with various groups, and updates and implements the Land Preservation, Parks and Recreation Plan. The Planning Commission, County Forestry Board, Ag Land Preservation Advisory Board, and the County Commissioners provide policy support, input, and guidance. Garrett County looks to work with the municipalities to apply for Land & Water Conservation Funds to supplement POS funding for larger projects.

Neither the County nor the municipalities have dedicated parks and recreation departments. The County depends on groups and organizations to operate and maintain County-owned parks. **CHALLENGES**

The County and Towns' lack of Parks & Recreation Departments means there are no dedicated staff to attend to parks, recreation, and trails related issues in the locally owned parks. In addition, the County and Towns rely on non-profits, and organizations like the Health Department, Garrett County Community Action, the Judy Center, and others to program events and activities in the parks. The Towns and County welcome use of their facilities for events. The Planning Department is working on developing a central map of all public recreation in the County along with a directory and possible calendar information to better plan, organize and market events and park sites.

If, at any point in time, the County takes on more responsibility for parks, trails and recreation facilities, the County will need to consider investing in creation of a Parks & Recreation agency with staffing. **BENEFITS**

Residents and visitors seek out these trails, fishing, hunting, events, and other recreation enhancing the County's tourism industry. Garrett County will continue to maintain and enhance parks and recreation systems for the environmental, economic, and health benefits for both residents and visitors.

Each year, visitors along with the residents substantially contribute to the County's economy and their own health, while keeping the County in pristine condition. These active recreation and outdoor based recreation activities are vital for the health and wellbeing of the population and also to keep visitors coming back to the County.

Progress from 2017

Table 12 above is a List of the Past Program Open Space Projects. Since the last update of the Land Preservation Parks and Recreation Plan the following projects have been completed:

Sang Run State Park - acquired 182 acres that supports diverse wildlife habitat and connects the park to the Youghiogheny River Natural Environment Area in Garrett County.

The acquisition of 1,986 acres in Garrett County will be managed as a new state park. Wolf Den Run State Park will provide a high-quality recreation experience and opportunity for off-highway/off-road vehicle riders. This purchase was made possible with a match from the National Park Service with a Land and Water Conservation Fund grant. Between the municipal parks, state lands and handful of County-owned, privately maintained facilities, the County offers a plethora of opportunity for year-round outdoor recreation. The County has supported requests for new trails and updated facilities, like the artificial turf fields at both Northern and Southern High School. The Towns and County cooperate to update facilities. Garrett Trails has continued their momentum to connect existing trail networks with the end goal of



having a trail network that covers most of the County and in parts can include a water trail (see all references to the Eastern Continental Divide Loop). Most notably, much work has been completed on the Meadow Mountain section which will eventually connect the Deep Creek State Park in the middle of the county with the town of Grantsville in the northern end of the county. Similarly, the State has also created trails for motorized off-road vehicles in Wolf Den, near Kitzmiller and St. Johns Rock. The County looks to cooperatively work with these groups to continue to provide trails to prevent conflicts with private landowners.

An Administrative Council composed of liaisons within the County, MDE and DNR has been specifically crafted for the implementation of a Watershed Management Plan¹¹ written for the Deep Creek watershed. The plan largely focuses on environmental stewardship but also contains elements relating to recreation. The establishment of this partnership is a model to be used in other watersheds and fosters a spirit of transparency and open communication with regards to projects, incentive programs and educational opportunities, not only between the agencies but also between the agencies and the public.

The Garrett County Board of Education participates in the POS program and uses available funds to maintain their facilities that are open to the public. In fact, over \$1.1 million in funding over the past 5-years have provided the students and the communities around Northern and Southern High school with artificial turf fields for youth sports. They have effectively scheduled the use of their facilities with local organizations and sports teams to ensure maximum utilization. POS is also funding updates to Yough Glades Playground. Board of Education also shares its Annual Facilities Master Plan with the County every year to continue long term planning and coordination for funding.

PROGRAMMING

Developing robust parks and recreation opportunities for the community is not only the physical parks and capital improvements, another topic to be strengthened is programming. Garrett County and the Towns partner with the community and its agencies to provide programming.

For example, The Garrett County Health Department recently launched the GC In Motion¹² an initiative designed to increase opportunities for people to be physically active by removing barriers for Garrett County residents. This comprehensive program utilizes community collaboration and is specifically designed to keep people moving with a variety of activities in 2022! This includes stipends awarded to

COUNTY GOALS

Access to public recreational open space and to a variety of active recreational opportunities promotes physical and mental health. Quality recreation facilities and opportunities enhance the quality of life for guests and visitors. In this regard, the provision of adequate recreational space and facilities is not simply a matter of providing for leisure time activities but is an essential part of maintaining public health, safety, and welfare, and promoting social and community cohesion. The County Land Preservation Parks and Recreation Plan Goals for Parks and Recreation remained the same for the 2017, 2012, 2005, and 1998 LPPR Plans. In this iteration of the plan, the County has updated the goals to recognize its accomplishments and to complement the County's Comprehensive Plan and the State's goals for parks and recreation. The Plan's public outreach, survey, and level of service analysis have informed the updates to the County's Park and recreation goals.

The County 2022 Parks and Recreation goals are as follows:

- GOAL 1: Provide diverse recreational experiences and opportunities readily accessible to residents and visitors, meeting current and future community needs.
- GOAL 2: Revitalize municipalities and community spaces to enhance residents' quality of life making Garrett County a desirable place to live work, play, and visit.
- GOAL 3: Maximize investments in public school facilities to support and complement community recreation opportunities to learn, play, and connect.
- GOAL 4: Promote non-profit organizations to provide inclusive recreation programming that contribute to the health and well-being of residents of all ages and abilities
- GOAL 5: Foster collaborative partnerships to leverage strengths and resources to expand, maintain, and promote an identifiable image of Garrett County recreation experiences for residents and tourists.
- GOAL 6: Expand the network of multi-use trails linking parks, schools, and community destinations to provide safe connections for transportation and recreation whilst decreasing the reliance on automobiles.
- GOAL 7: Determine the need for an oversight for County parks and recreation. Work with the local municipalities and other local agencies to collectively market, maintain and develop resources and services to provide the best recreational experience for residents and visitors of Garrett County.

The County is undertaking its update of the Comprehensive Plan and recreation, parks, and trails as a component of the plan to assure that growth areas have adequate facilities and facilities that continue to



be addressed to meet the community's recreation needs.

STATE GOALS

- Make a variety of quality recreational environments and opportunities readily accessible to all of its citizens and thereby contribute to their physical and mental well-being.
- * Recognize and strategically use parks and recreation facilities as amenities to make communities, counties, and the State more desirable places to live, work, play and visit.
- Use state investment in parks, recreation, and open space to complement and mutually support the broader goals and objectives of local comprehensive/master plans.
- To the greatest degree feasible, ensure that recreational land and facilities for local populations are conveniently located relative to population centers, are accessible without reliance on the automobile and help to protect natural open spaces and resources.
- * Complement infrastructure and other public investments and priorities in existing communities and areas planned for growth through investment in neighborhood and community parks and facilities.
- Continue to protect recreational open space and resource lands at a rate that equals or exceeds the rate that land is developed at a statewide level.

County and State Goals for Parks and Recreation Comparison

The County's and State's goals are aligned in addressing both specific and general aspects of recreation planning, such as preserving open space, natural resources, and meeting the needs of the community to make Garrett County and Maryland a place that is desirable to live, work and play. The County goals for parks and recreation mirror or slightly differ from the State's goals to promote access to recreation and encourage redeveloping facilities. Both sets of goals address access to recreational opportunities without reliance on the automobile.

CAPITAL IMPROVEMENT PLAN

The projects listed in the Capital Improvement Plan tables below note which parks and recreation goals they address.

Short Term FY 2022-2026

The 2022-2026 Parks and Recreation Capital Improvement Plan (CIP) includes future recreational projects from the input from public outreach sessions, organizations maintaining and developing parks, the Towns, and the County's 2021 Transportation Priority Letter. The Parks and Recreation CIP contains only the current recreational proposals submitted by the County's municipalities. Entries in the plan for FY 2022 include municipality projects in the FY 2022 Annual Plan for Program Open Space AND FY 2022 Local Parks and Playgrounds Grant.

The CIP projects in the table list the County's recreations goals, to address the conclusions made from the public outreach and level of service analysis through the Couty's seven recreation goals.

As illustrated in the County-wide Recreation Survey, many parks need new equipment and amenities, known as Capital Redevelopment. The County's long-standing goal of improving existing parks accounts for much of the Program Open Space funding and Community Parks and Playgrounds funds where applicable.

Many of these projects improve access, through extending the times the facility can be used by adding lighting, weatherization improvements to extend seasons, or renovations that will provide better accessibility through universal design standards. Connectivity Trails and paths were requested from the public outreach, these community playground projects will try to incorporate walking paths and trails that communities can access without the reliance on automobiles. CHAPTER 3 NATURAL RESOURCE LAND CONSERVATION EXECUTIVE SUMMARY

Garrett County is unique in the State because 90% of its land (377,496 acres) is resource land including 284,457 acres of forest 83% of the total County size 419,293 acres¹³. Indeed, recreational activities of County and visiting citizens are a significant factor supporting its economy. While these resource lands provide scenic beauty, sustain the existing ecosystem, support carbon sequestration, they contribute to the local economy through the forest products, and tourism industries. Benefits of the resource lands include improving land resilience, carbon dioxide sequestration, filtration of both air and water, wildlife habitat, biodiversity, reduced vulnerability to fire and insect threats and protection to environmentally sensitive areas. These lands require continued and enhanced preservation attention of private landowners as well as County, State, and Federal sources.

The former location of the Mountain Lake owned by the Town of Mountain Lake Park, is undeveloped conservation land near Broadford Park; there are existing plans to create a boardwalk and interpretive trails in this area. In addition, the Town of Mountain Lake Park owns 50 acres of conservation land adjacent to the Loch Lynn trail. There is opportunity to develop this conservation land for people to connect with nature and build the system of local trails.

Due to the high proportions of open space and protected land, Garrett County has no challenges providing citizens with opportunities to engage in natural spaces. Citizens and visitors to our County can recreate in the many State, municipal, or privately managed parks, mentioned in the previous chapter. Garrett County offers scenery enhanced by the open space protected under various preservation and easement programs, or they can choose to learn more about agriculture, culture, and history through various agritourism, historical and interpretive history opportunities. While existing opportunities abound, where additional opportunities may present themselves, especially regarding education, and tourism, the County will help facilitate bringing those opportunities to fruition.

FORESTED MANAGEMENT

Private and cooperate ownership of Garrett County's forests account for 68% of the land cover and 49% of those forests are enrolled in a Forest Stewardship Plan¹⁴, either through the MD DNR - Forest Service or through a consulting forester. A Forest Stewardship Plan (FSP) helps landowners identify and understand the value of their forestland and better predict the effects of any resource harvesting or disturbance of the land. Managing forest resources properly ensures sustainability of a natural living system and a range of possible benefits beyond the simple beauty of nature, including improved water and air quality, wildlife viewing and habitat for a variety of species, hunting and trout fishing opportunities, timber harvest, as well as fruit and nut production.

Potomac, Garrett, and Savage River State Forests are dual-certified by the two major internationally




recognized forest certification systems for public land, the Forest Stewardship Council (FSC) and the Sustainable Forestry Initiative (SFI). The certification process involves a detailed review of the

environmental, social, and economic values of the forests so they can remain healthy and viable into the future.

The Maryland Forestry Economic Adjustment Strategy (EAS) Report¹⁵ outlines how Maryland can foster a resilient and sustainable transition by rebuilding and modernizing the forest products industry. This reports highlights Maryland's unique assets, resource diversity, and environmentally engaged consumers to build sustainable markets for Maryland's forest product entrepreneurs.

Wild Lands

State Designated Wild Lands are designated by the General Assembly as wildlands areas. These lands are managed for passive recreation such as, including hiking, hunting, fishing, bird watching, horseback riding and nature interpretation. Ten of the State's 38 designated wildlands are in Garrett County totaling 15,909 acres. Most of these sites are classified as Type 1, meaning a primitive area which by its size and location is in effect untouched by urban civilization and can offer the experience of solitude and self-reliance. Type 1 wildlands are usually lands located at higher elevations that protect watersheds and are ecologically vulnerable to human interferences. ¹⁶

Youghiogheny Wild and Scenic Corridor

The Youghiogheny River Corridor is a unique environmentally sensitive area and recreational resource and has been protected by the State through the Scenic and Wild Rivers System Act, since 1968. In1971, the Youghiogheny River was designated as a Scenic River into the State System. In 1976, a 21mile-long segment, from Miller's Run just north of Oakland to the town of Friendsville was designated as Maryland's first Wild River. This corridor is managed by the Maryland Park Service to preserve the wild and natural scenic, geologic, historic, ecologic, recreational, fish, wildlife, and cultural resources. The remaining portions of the Youghiogheny River Corridor (YRC) are designated as the Scenic River , which is defined as a "free-flowing river whose shoreline and related land are

predominantly forested, agricultural, grassland, marshland, or swampland with a minimum of development for at least 2 miles of the river length "¹⁷ A Wild River is defined a "free-flowing river whose shoreline and related land are undeveloped, inaccessible except by trail, or predominantly primitive in a natural state for a least 4 miles of the river length"¹⁸

More details of the management of the YRC can be found in 1996 Maryland Scenic and Wild Rivers¹⁹: The Youghiogheny. The County's responsibility in this Plan was to form the Youghiogheny River Advisory Board (YRAB), participate as a voting member of the Board, participate as an officer on the Board on a rotating basis, and to provide technical assistance to the Board. The YRAB is responsible for carrying out the management plan and performs a key role for citizen input in the management decisions.

Deep Creek Lake Watershed

The Deep Creek Lake area is a unique and special place. The 3,900-acre freshwater lake is the largest in Maryland and is set amid scenic mountains and stream valleys. The combination of water, mountains, and forests in the Lake area offers year-round recreation opportunities but is most popular during the summer months. The Deep Creek Lake area has become the County's most important economic engine and is an increasingly popular place for new year-round and seasonal housing. Owned by the state of Maryland, the Department of Natural Resources (DNR) is responsible for managing the lake and buffer zone. However, many concerns extend beyond the authority of the State-owned property, and a result, the County, Maryland Department of the Environment (MDE) and DNR, along with other stakeholders prepared the Deep Creek Lake Watershed Management Plan (WMP), which was adopted in 2016. As of the writing of this Plan, the WMP remains the most significant plan relative to the future water quality and economic vitality of the Lake. The Deep Creek Watershed Management Plan serves as a comprehensive assessment of community issues about land use, water quality, recreation, stormwater, septic and

sewerage, and impacts from growth within the Deep Creek Lake Watershed. It proposes recommendations for policy changes, restoration actions, best management practices, and public outreach to address these concerns. Even with the modest growth, over the years, the Deep Creek Lake community, the County and DNR have shown a growing interest in ensuring that the quality and recreational value of the lake is maintained.

ADMINISTRATIVE COUNCIL

The WMP provides a course for protecting, enhancing, and restoring the resources of the Deep Creek watershed. The plan sets forth strategic goals along with the needed action and a timeframe for addressing them. Some actions are already completed and underway through State or County management. Most importantly perhaps, has been the progress in establishing the organizational infrastructure to advance and implement the goals, objectives, and strategies of the WMP. First and foremost was the establishment of the Administrative Council (AC), which is comprised of representatives of the three main governmental agencies with regulatory control within the watershed - Garrett County, the Maryland Department of the Environment (MDE) and the Maryland Department of Natural Resources (DNR). The AC was formalized via the signing of an initial Memorandum of Understanding in 2016 and a signing of a second Memorandum of Understanding in 2018, which continued the agency collaboration. The third Memorandum of Understanding expires on February 2023. The primary charge of the AC is to oversee the implementation of the WMP by ensuring project design, funding, and oversight is provided and administered by the appropriate individuals in every agency. In addition, AC representatives attend meetings of other local organizations to educate others on the environmental and economic importance of the Lake and its watershed, to provide information on resources to advance the WMP and to coordinate activities as needed. The AC meets monthly and provides an Annual Report to the Garrett County Commissioners. Garrett County is looking to fill a Watershed Coordinator position to serve as staff to the AC and to also act as the liaison between the AC and local stakeholders.

EDUCATIONAL ADVISORY COMMITTEE

The WMP recognized the importance of engaging private property owners to encourage voluntary best management practices within the watershed rather than relying on a top-down regulatory approach. The AC also recognized the importance of receiving advisory input from citizens regarding the opportunities to improve communication through public education, information exchange and citizen engagement. As such, in 2017 the Educational Advisory Committee (EAC) was formed to continually assess the community's communication and outreach needs and to report those needs to the AC. The EAC is comprised of 8-10 volunteers representing agriculture, business, education, forestry, marketing, recreation, and property owners within the watershed.

MARYLAND'S STATE LAKES PROTECTION AND RESTORATION FUND

During the 2018 Maryland legislative session, Senator George Edwards and Delegate Wendell Beitzel spearheaded SB 501 and HB 801 and Governor Hogan approved \$1,000,000 annually for three years for the State Lakes Protection and Restoration Fund. In the 2022 legislative session, another three years of \$1 million annually was added to the Fund.

These funds are intended to protect and restore Maryland State-owned



or managed lakes. The Department of Natural Resources was tasked with developing a budget and



projects for best utilizing these funds in coordination with local governments, organization, and citizens. The purpose of the funds is to protect State-owned lakes by removing sediment, treating contaminated sediment, preventing the spread of invasive species, improving ecological and recreational value, and taking any other action deemed necessary to protect the lakes.

Deep Creek Lake, as the largest lake in Maryland and the economic engine for western Maryland received approximately \$1.5 million for protection and restoration activities over the first three years of the program. Specifically, the funds provided Deep Creek Lake have supported the chemical treatment for eradicating *Hydrilla*, an invasive aquatic vegetation, offsetting homeowner costs for installing shoreline stabilization structures for controlling sediment erosion and providing fish habitat.

Other Garrett County lakes available to receive funding from the Fund are Herrington Lake, New Germany Lake and Savage River Reservoir.

DEEP CREEK LAKE WATERSHED FOUNDATION

During the development of the WMP, it became apparent to the Steering Committee formulating the plan that the County, DNR and/or MDE would not be able to provide or sustain the funding necessary to implement the efforts, programs and projects recommended in the WMP. To address this need, the Deep Creek Watershed Foundation (the Foundation) was formed in 2016. The Foundation is a 501(c)(3) organization whose goal is to engage in fundraising activities to sponsor educational programs, to support scientific initiatives and to apply for grants in furtherance of implementing the goals of the WMP. To this end, the Foundation has raised funds for several projects that advance the WMP.

GOALS

Natural resource conservation lands provide many environmental and social benefits including natural filtration of air and water, outdoor recreation opportunities, economic and public health benefits, and wildlife habitat and biodiversity. Preserving natural resources sustains a functioning ecosystem, which in turn provides benefits to all humans, including but not limited to improved resilience, reduced vulnerability, improved *FIGURE 35 FIGURE 33 BOATING ON DEEP CREEK LAKE*

sediment transport and better water quality.

Garrett County's Sensitive Areas Goal as stated in the Sensitive Areas chapter of the County's 2008 Comprehensive Plan is to "continue to protect Garrett County's sensitive environmental resources and natural features". The 2017 Garrett County LPPRP reiterated this goal and the following objectives for achieving the goal:

- Limit development in and near sensitive environmental areas, including steep slopes, streams, wetlands, 100-year floodplains, and the habitats of threatened or endangered species.
- Conserve agricultural and forest resource land.
- Protect scenic resources.
- Support increased use of soil and water conservation practices.
- Preserve 20,000 acres of farmland by 2020.
- Protect public wellhead resource areas.
- Continue to provide public input and information to protect resources through existing Board and groups.

The State goals for natural resource lands conservation preservation are as follows:

- Identify, protect, and restore lands and waterways in Maryland that support important aquatic and terrestrial natural resources and ecological functions, through combined use of the following techniques:
 - Public land acquisition and stewardship.
 - Private land conservation easements and stewardship practices through purchased or donated easement programs.



• Local land use management plans and procedures that conserve natural resources and environmentally sensitive areas and minimize impacts to resource lands when development occurs.

- Support incentives for resource-based economies that increase retention of forests, wetlands, or agricultural lands.
- Avoidance of impacts on natural resources of publicly funded infrastructure development projects; and
 - Appropriate mitigation response, commensurate with the value of the affected resource.
- Focus conservation and restoration activities on priority areas, according to a strategic framework such as the Targeted Ecological Areas (TEAs) in GreenPrint (which is not to be confused with the former easement program also called GreenPrint).
- Conserve and restore species of concern and important habitat types that fall outside of designated green infrastructure (examples include: rock outcrops, karst systems, caves, shale barren communities, grasslands, shoreline beach and dune systems, mud flats, non-forested islands, etc.)
- Develop a more comprehensive inventory of natural resource lands and environmentally sensitive areas to assist state and local implementation programs.
- Establish measurable objectives for natural resource conservation and an integrated state/local strategy to achieve them through state and local implementation programs.
- Assess the combined ability of State and local programs to achieve the following:
 - Expand and connect forests, farmlands, and other natural lands as a network of contiguous green infrastructure;
 - Protect critical terrestrial and aquatic habitats, biological communities, and populations;
 - Manage watersheds in ways that protect conserve, and restore stream corridors, riparian forest buffers, wetlands, floodplains, and aquifer recharge areas and their associated hydrologic and water quality functions;
 - Adopt coordinated land and watershed management strategies that recognize the critical links between growth management and aquatic biodiversity and fisheries production; and
 - Support a productive forestland base and forest resource industry, emphasizing the economic viability of privately owned forestland.

Progress to date



The County maintains the 2017 goals in this update to the LPPRP and continues to work towards them mainly through the administration of several adopted Ordinances, which are listed in total in Section 5 of this Chapter. The Sensitive Areas Ordinance helps conserve important natural features by providing regulations regarding steep slopes; stream buffers; wetlands; floodplains; source water protection areas and habitats of rare, threatened, and endangered species. Garrett County's Floodplain Management Ordinance, Stormwater Management Ordinance, and Sediment & Erosion Control Ordinance also help to protect important natural resources and provide for increased use of soil and water conservation practices. Conservation of agricultural land and protection of farmland are discussed in the next chapter. County goals mostly complement the State Goals. An example of cooperation towards achieving these shared goals is evidenced by the County, MDE, and DNR partnering to develop a comprehensive watershed management plan for Deep Creek Lake. Completed in 2014 and updated in 2016, The Deep Creek Watershed Management Plan will serve as a comprehensive, best practices guide to protect the lake's sensitive natural resources and address water quality and recreational activities. One of the goals of the Plan was to "manage stormwater infrastructure to decrease pollution from both existing and proposed development to ensure healthy watershed conditions". To help achieve this goal, the County completed a stormwater assessment of the North Glade Watershed that identified locations of excessive erosion, their sources, and recommended solutions for remediation. The intent of the County is to obtain a model for assessment that can be repeated in other sub watersheds in the future.



MAP 13 PRESERVED & PROTECTED AREAS IN GARRETT COUNTY



Tier Map

The Maryland General Assembly approved the Sustainable Growth & Agricultural Preservation Act of 2012 (Senate Bill 236) during the 2012 General Assembly session. The law, which took effect on July 1, 2012, is sometimes referred to as the Septic Bill since it seeks to limit the spread of residential development on septic systems.

The Act required all jurisdictions, including Garrett County, to adopt land use categories called Tiers. The Tiers were created based on certain criteria in the Act that established where major and minor residential subdivisions may be located and what type of sewerage system will serve them. No major subdivision (greater than 7 lots) can be located in lands designated as Tier 4. All subdivisions submitted on or after December 31, 2012 must comply with the Tier Map and other provisions of the Act.




MAP 14 TIER MAP 2012




MAP 15 TARGETED GROWTH & CONSERVATION



Priority Funding and Targeted Ecological Areas


1997 Planning Legislation capitalizes on the state's influence on economic growth and development. This law directs state spending to Priority Funding Areas (PFA). Priority Funding Areas are existing communities and places designated by local governments that states where they want state investment to support future growth. Targeted Ecological Areas are a limited number of areas that rank exceptionally high for ecological criteria and that have a practical potential for preservation. The criteria for PFAs are set by the MD Department of Planning, while the criterion for targeted ecological areas is set by the MD Department of Natural Resources.



IMPLEMENTING ORDINANCES AND PROGRAMS

The following ordinances and programs are used by the County to work towards achieving its goals for the conservation of natural resource land:

- <u>2008 Garrett County Comprehensive Plan-</u> Encourages development in suitable areas and promotes the protection of sensitive areas and resources areas.
- <u>Deep Creek Watershed Zoning Ordinance</u>- Encourages orderly development, appropriate use of lands, and promotes the conservation of natural resources within the Deep Creek Watershed.
- <u>Garrett County Sensitive Areas Ordinance</u>- Provides regulations regarding steep slopes; stream buffers; rare, threatened or endangered species; wetlands, and source water protection areas as shown on Sensitive Areas Maps 1 and 2.
- <u>Garrett County Subdivision Ordinance</u>- Establishes development standards with a focus on preserving natural features.
- <u>2010 Stormwater Management Ordinance</u>- Establishes minimum requirements and procedures to control the adverse impacts associated with increased stormwater runoff and help restore, enhance, and maintain the chemical, physical, and biological integrity of streams.
- <u>2013 Erosion & Sediment Control Ordinance</u>- Establishes minimum requirements and procedures to control the adverse impacts of land development on water resources and help maintain the physical and biological integrity of streams.
- <u>2019 Garrett County Floodplain Management Ordinance</u>- Establishes regulations for floodplain development, helping to protect the vital functions of floodplains including maintenance of water quality, prevention of erosion, habitat for diverse natural wildlife populations, recreational opportunities, and aesthetic quality.
- <u>2014 Garrett County Water and Sewerage Master Plan</u>- stipulates services should not be extended where this would allow inappropriate growth in areas where the Comprehensive Plan calls for conservation of resource land.

SUMMARIES OF DEFICIENCIES AND RECOMMENDATIONS

The County's unique, sensitive, and valuable natural resources land are abundant. Special care will continue to be taken when locating development in these areas for recreational or economic development. In addition, the County continues to support the monitoring of these sensitive areas and to play a role in proactively mitigating any minor issues to maintain natural resource lands. For example, The County has received funding from DNR to dredge Arrowhead Cove in Deep Creek Lake. Concurrently with this project the County is looking for grants and projects upstream of the cove to reduce sedimentation from "undoing" the dredging work.

CHAPTER 4 AGRICUTURAL LAND PRESERVATION

Garrett County has a long history of agriculture since the County's creation when it was split from Allegany County in 1872. Approximately one-fifth of the County's land cover is Agriculture (88,953.83 acres). Since 1973 the County has seen a loss in agricultural land cover of 13,718 acres. The County has not adopted zoning regulations that would severely limit the develop of agricultural land. Instead, the County has used Agricultural Land Preservation Programs to save farmland. Garrett County

officials recognize that farms are a public benefit by helping to continue this tradition and by protecting valuable farmland for future generations. Agricultural easements are currently acquired under three programs in Garrett County: the Maryland Agricultural Land Preservation Foundation (MALPF); Rural Legacy; and the Maryland **Environmental Trust** (MET).

The first land preservation

easement sponsored by Garrett County occurred in 1983 with the purchase of the development rights of the Mason Farm located south of Oakland. This program preserves agricultural land by working with private landowners to sell their development rights to MALPF while retaining the right to continue to use the land for farming. There are currently 71 MALPF easements within the County totaling 8,890.5 acres.

Maryland's Rural Legacy (RL) program was created in 1997 to protect large, contiguous tracts of Maryland's most precious cultural and natural resource lands though grants made to local applicants for land and easement acquisitions. Garrett County's 31,000-acre Rural Legacy Area covers the Bear Creek watershed near the town of Accident. There are currently 16 Bear Creek Rural Legacy easements totaling 1,650 acres.

The Maryland Environmental Trust (MET) is a land trust that acquires easements (by purchase or donation) on agricultural and natural resource lands throughout the state. MET holds approximately 21 easements in the County covering approximately 2,448 acres. The County is not directly involved with administration of MET easements

Garrett County has also adopted the Garrett County Agricultural Land Preservation District program to preserve productive local farmland and woodland. Districts are in effect for a minimum of 3 years and help screen and pre-qualify landowners wanting to sell a perpetual conservation easement to MALPF or Rural Legacy. Approved District properties are also eligible for a County Tax Credit on all agricultural lands and woodlands. There are currently 29 Districts totaling 4,413.75 acres.

COUNTY GOALS

County goals for agricultural land preservation found in the 2008 Comprehensive Plan are to conserve agricultural and forest resource land (page 3-1) and preserve 20,000 acres of farmland by 2020 (page 7-1). As of the end of 2020, the County had a total of 16,937 acres preserved. The County will continue to strive for this goal, by 2025. Currently there are a total of 6 farms and over 1,0000 acres in the Agricultural District Process and or working for a permanent easement.

From 2008 through 2017 there were no new easements on properties with active gas leases in the Bear Creek Rural Legacy Area due to concerns over potential development of Marcellus Shale natural gas reserves., DNR revisited that policy, and in 2018 and allocated additional funding to purchase easements provided the land is not deemed to be at high risk for shale development. This fund has preserved over 300 acres during its grant cycle.


STATE GOALS

- Permanently preserve agricultural capable of supporting a reasonable diversity of agricultural production;
- Protect natural, forestry and historic resources and the rural character of the landscape associated with Maryland's farmland;
- To the greatest degree possible, concentrate preserved land in large, relatively contiguous blocks to effectively support long-term protection of resources and resource-based industries;
- Limit the intrusion of development and its impacts on rural resources and resource-based industries;
- Ensure good return on public investment by concentrating state agricultural land preservation funds in areas where investment is reasonably well supported by both local investment and land use management programs;
- Work with local governments to achieve the following
 - Establish preservation areas, goals and strategies through local comprehensive planning processes that address and complement state goals;
 - In each area designated for preservation, develop a shared understanding of goals and the strategy to achieve them among rural landowners, the public-at-large and state and local government officials;
 - Protect the equity interests of rural landowners in preservation areas by ensuring sufficient public commitment and investment in preservation through easement acquisition and incentive programs;
 - Use local land use management authority effectively to protect public investment in preservation by managing development in rural preservation areas;
 - Establish effective measures to support profitable agriculture, including assistance in production, marketing and the practice of stewardship, so that farming remains a desirable way of life for both the farmer and the public-at-large.

COMPARISON OF COUNTY AND STATE GOALS

Generally, Garrett County's goals for Agricultural Land Preservation are relatively consistent with the State Goals shown above. Since the County does not have County-wide zoning, the County has limited land use management authority to limit the control of development in most rural areas, though the County continues it efforts in using temporary and permanent land preservation easements as tools in saving productive agricultural lands.

ADDITIONAL AGRICULTURAL LAND PRESERVATION GUIDELINES

The following section evaluates strategies and actions (in italics) presented in the 2017 LPPRP and describes whether or not they were implemented.

- Continue to support the purchase of agricultural easements. The County has continued to assist landowners wishing to pursue agricultural easements through the MALPF program. Since 2008, the County's support of easements in the Bear Creek Rural Legacy Area and DNR have allocated funding to the County purchase more easements provided the land is deemed to be at low risk for shale gas development.
- Encourage development to occur in designated Priority Funding Areas (PFAs) and clustering of new housing development in locations outside designated PFAs. Garrett County continues to encourage development to occur in PFAs. This goal has been difficult to achieve by the fact that only a small percent of the County is located within PFAs. The 2008 Comprehensive Plan included options for clustering of new lots that included density incentives in the Agricultural and Rural Resource Areas. The subdivision restrictions forced on the County by the Agricultural Land Preservation Act of 2012 have severely undermined these provisions. There is no longer any incentive for clustering due to the Act's prohibitions against major subdivisions in most areas of the County. The County is working on an update to the Comprehensive Plan. Development patterns and trends are being reviewed and ordinance changes will be considered if warranted.
- Encourage farmers who must sell their farms to sell to other farmers. This recommendation would have established a farm brokerage program matching older farmers with younger ones and sellers with prospective farmer buyers, including an incubation program that would link new farmers with established farmers who might assist in transitioning ownership or purchase of farm equipment over an extended period. This recommendation has not been implemented. Garrett County's farm turnover rate is low and usually involves family transfers precluding the current need for a farm brokerage program. Since the County has limited involvement in the sale of private land this does not appear to be a relevant goal for the future.
- Continue to avoid extension of public water and sewer facilities into prime agricultural areas. The 2008 Comprehensive Plan stated that no extensions of public water or sewer services would be permitted in land designated AR and RR except to correct health or safety problems in existing developed areas (pages 3-12 and 3-13). The 2014 Garrett County Water and Sewerage Master Plan adopted on December 9, 2014 reiterated and formalized these restrictions.
- Continue to participate in the Rural Legacy program to extend the resources available through MALPF to purchase easements on farmland and forest in the Bear Creek watershed.
 - Continue to utilize the County Tax Credit Program to provide incentive to farmers to maintain Agricultural Preservation Program Districts and to encourage formation of additional designated Agricultural Preservation Districts. Garrett County continues to utilize both programs. A Garrett County District Agreement is a voluntary agreement that remains in effect for a minimum of three years. The District Agreement provides the security of knowing that the land is protected from development and is a valuable first step in securing more permanent protection. Approved District properties are eligible for a County Tax Credit on all agricultural lands and woodlands. Taxes continue to be assessed on all residential and agricultural structures but the property tax on all real estate is 100% rebated under the program. Garrett County currently has a total of 29 Districts containing approximately 4,413.7 acres. Fourteen of these Districts are taking advantage of the County Tax Credit Program. Seven of these District properties have pending MALPF easement applications.
- Encourage formation of a private, non-profit Local Land Trust to support current efforts to protect farmland. The Allegheny Highlands Conservancy (AHC) was formed in 2004 with a mission "To conserve the natural resources, scenic beauty, and rural character of the Allegheny



Highlands of Maryland". AHC partnered with the Maryland Environmental Trust (MET) to protect ten properties and over 1,200 acres in Garrett County. In August of 2015 the board of the AHC voted to dissolve the organization and transfer all of AHC's remaining assets to MET. An August 20, 2015 press release from AHC cited factors such as reduced interest in land conservation, the potential impact of Marcellus shale gas extraction and decreased interest and participation in the organization as factors that limited their viability. Although Garrett County would continue to support local land trusts, the experience of AHC indicates that such groups may not be feasible. Therefore, encouraging formation of such groups may not be a practical future goal.

The update of the Garrett County Comprehensive Plan will not establish priority preservation programs. The County's goals are implemented through the Garrett County Subdivision Ordinance and Deep Creek Watershed Zoning Ordinance by establishing lot size requirements. The County monitors the effectiveness of these programs during review of the Comprehensive Plan.

SUMMARY OF DEFICIENCIES AND RECOMMENDATIONS

For Garrett County to reach its land preservation goals, streamlining the Agricultural Land Preservation process for the County and for landowners will make it more achievable. The following recommendations are specific actions to improve the current processes.

- 1. Consider Rural Legacy Area and Agricultural Districts separately
 - a. Rural Legacy properties currently must meet the Agricultural District Soil requirements. In order for the County to protect this sensitive area of Bear Creek it should look to preserve the entire area and should eliminate Agricultural District Soil requirements. Other environmental, historic, and scenic values should be evaluated in its place to prioritize properties in this area. Also, for potential Rural Legacy Easements they would not have an Agricultural District and therefore the property owner would not be eligible for the tax credit, unless they go through this process.
- 2. The current timeline for landowners from an inquiry to creation of Agricultural District can be up to one year. The result of several reasons such the time reired for a complicated soils analysis.
 - a. The County will work with Soil Conservation District to create a digital map product to quickly determine if property is eligible for Agricultural District and the MALPF program.




Figure 45 Public Input Board Developed for Loch Lynn Outreach
