



CONSERVATION FINANCE 101

The term "conservation finance" is popping up everywhere, but it can be difficult to understand what it means let alone how it applies to your work. This 101 overview will run through the range of innovative--or just plain effective--funding and financing tools and strategies, including examples of how each has been put into practice. We will also point towards trends and updates in the field, particularly those relevant to Maryland. The session will attempt to demystify conservation finance, and will provide attendees with a practical resource library of toolkits, reports, and other resources to continue their exploration.

MARYLAND'S FOREST CONSERVATION ACT AND THE IMPACT ON RESIDENTIAL DEVELOPMENT AND FOREST COVER CHANGE

Forest resources provide numerous benefits to the residents of Maryland. Starting in 1993, Maryland's Forest Conservation Act (FCA) mandated afforestation and conservation requirements on parcels undergoing development. We analyze the effectiveness of the FCA in rural Baltimore County, including forest cover change for subdivisions in the baseline period prior to the FCA and after the FCA. Our results indicate that, after the FCA regulation, forest cover increased by 21% within subdivisions relative to the amount without the regulation. Parcels with the highest levels of forest cover continue to have significant forest losses, despite the FCA regulations. Because regions with the most intact forest cover are those least protected by the FCA regulations, land trusts and conservation practitioners must conserve high priority forested areas using other approaches including purchase of development rights or conservation easements.

A current board member of the Chesapeake Conservancy, Dr. Mamie Parker is the former Assistant Director of Fisheries and Habitat Conservation at the U. S. Fish and

Wildlife Service (FWS). Prior to this position, she made history when appointed the first African American as FWS Regional Director of the 13 Northeastern states. Dr. Parker has an extensive amount of experience as a fish and wildlife biologist and an executive, which led her to receiving the annual Ira Gabrielson Award, an award given by FWS leaders to the most outstanding leader. The President of the United States presented Dr. Parker, a Senior Executive Service member, with the Presidential Rank award, the highest award given to government employees. Parker is a leader in various organizations and serves on the Board of Directors of the National Wildlife Refuge Association; and Defenders of Wildlife; and serves on the Chesapeake Conservation Partnership Steering Committee.

HOW THE OVERHEAD MYTH HURTS NONPROFITS AND WHAT CAN BE DONE ABOUT IT

How many times have you heard that nonprofits that keep operational costs low are somehow better or more effective at accomplishing their missions than those who don't? Fifteen years of research shows this pervasive claim to be a myth. The best nonprofits are those whose funders support operating costs in their grants. This session will explore the origins of the myth, how it undercuts effectiveness, and strategies for debunking it. In particular, we will see a case in point of how NeighborSpace employed these strategies to influence its largest funder to completely remove a long-standing cap on how much the organization could spend on its overhead expenses and what that has meant for organizational capacity.

AGRICULTURAL CONSERVATION LEASING PROJECT

The Agriculture Law Education Initiative and the Harry Hughes Center for Agro-Ecology, Inc. launched the Agricultural Conservation Leasing Project in early 2019. The Project consisted of five regional workshops in which farmers, landowners and agricultural service providers learned how to use a farming lease to foster conservation practices on leased land. The Project highlighted the challenges of implementing conservation practices on leased farmland and the need for further outreach with landowners on this important subject. Conservation professionals, using the Project's resources and educational materials, can facilitate communication between landowners and farmers and initiate greater implementation of conservation practices on Maryland's leased farmland.
