2022-23 Application for Deal Island WMA Impoundment Hunts

A person may not hunt in the Deal Island impoundment unless he/she first obtains a permit. To apply for a permit through the lottery drawing, follow the directions below to complete this application:

- Print all information clearly and legibly. Any illegible, incomplete, duplicate, or faxed applications will be disqualified.
- A.) Indicate your choice of up to 4 days in order of priority by placing a 1,2, 3, or 4 in the box with the dates you prefer.
- B.) If none of your date choices are available when your application is drawn, you may accept being assigned the first available open date still remaining by circling "Yes", in the box provided.
- C.) Fill in your name, complete mailing address, hunting license number / DNR ID number, and driver's license number.
- D.) Sign your application.
- E.) Attach a copy of your 2022-23 MD Hunting License and MD Migratory Game Bird Stamp.
- Place your application in a legal sized envelope along with a self addressed stamped envelope and mail to:

IMPOUNDMENT HUNT PERMIT RULES & REGULATIONS

1. The person named on the permit must be present the day of the hunt. This permit is non-transferable.

2. The permit holder must have the permit on his/her person while hunting, and may bring two (2) other persons as guests while hunting. All persons must hunt together as one (1) party. All guests must sign the permit.

3. Hunters must fill out the sign-in sheet located at the impoundment parking lots at Deal Island WMA, or see attendant before hunting on permit days.

4. Hunters may not enter the impoundments earlier than two and one half (2 ½) hours before sunrise and must be off the waters and dikes of the impoundments by one and one-half (1 1/2) hours after sunset.

5. The impoundment at Deal Island WMA will be open to hunting during the 2022-23 hunting season as follows:

September Resident Goose Season Youth / Veteran / Military Waterfowl hunts First Duck Season Segment

Second Duck Season Segment

Third Duck Season Segment

September 1 through September 15, 2022. November 5, 2022 and February 4, 2023. Opening day and Saturdays (by permit only).

Opening day, Saturdays, and the Friday after Thanksgiving (by permit only).

Opening day, Saturdays in December, Wednesdays and Saturdays in

January (by permit only).

6. Motorized boats, except those powered by electric motors, are prohibited in the Deal Island and Fairmount WMA impoundments between October 1 and March 31.
